

TERMS AND CONDITIONS POLICY

Binding of Terms:

This website is owned and operated by Copper Ridge Event Center. These Terms set forth the terms and conditions under which you may use our website and services as offered by us. Website use Requirements:

Purchasing Requirements/Agreement:
